



## **MANUFACTURER'S CERTIFICATION STATEMENT For Timeless Products placed in use from January 1, 2010 to December 31, 2010**

Section 25C of the Internal Revenue Code (the "IRC") permits taxpayers to claim a limited tax credit with respect to amounts paid or incurred to purchase "Eligible Building Envelope Components" as that term is defined in IRC § 25C. The tax credit was amended by Section 1121 of H.R.1, "The American Recovery and Reinvestment Act of 2009".

IRS Notice 2009-53 sets forth the requirements for a Manufacturer's Certification Statement. The taxpayer may rely on this Statement that certain Timeless windows and doors are Eligible Building Envelope Components. The taxpayer is not required to attach this Statement to their tax return. However, the taxpayer should retain this Statement for their records.

The manufacturer of Timeless windows and doors is Gorell Windows & Doors, LLC, 1380 Wayne Avenue, Indiana, PA 15701.

IRS Notice 2009-53 provides guidelines for determining what energy-efficient improvements qualify for the tax credit. Pursuant to these guidelines, Gorell has identified the following Timeless windows and doors as Eligible Building Envelope Components that qualify for the tax credit allowed under § 25C when installed as an exterior window or door of the taxpayer's primary residence:

### **3000 Series: Models 3001, 3002, 3003, 3004, 3007, 3008, 3011, 3012, 3013**

- **All units incorporating one of the following glass systems:** AC Master, Eco Master, Armor Glass Plus, Energy Master III, Solar Master III, Thermal Master III or Ultra Master III—with or without Grids.

### **5000 Series: Models 5002, 5003**

- **All units incorporating one of the following glass systems:** Eco Master, Armor Glass Plus, Energy Master III, Solar Master III or Thermal Master III—with or without Grids.

### **5000 Series: Model 5004**

- **All units incorporating one of the following glass systems:** AC Master, Eco Master, Armor Glass Plus, Energy Master III, Solar Master III or Thermal Master III—with or without Grids.

### **5000 Series: Models 5111, 5112**

- **All units incorporating one of the following glass systems:** Energy Master III or Thermal Master III—with or without Grids.

### **5050 Series: Models 5051, 5052, 5053, 5054**

- **All units incorporating one of the following glass systems:** Eco Master—with or without Grids.

### **Timeless Series: Models TMDHS, TMDHP, TMHS, TMTS**

- **All units incorporating one of the following glass systems:** Eco Master, Armor Glass Plus, Energy Master III, Solar Master III, Thermal Master III or Ultra Master III—with or without Grids.

### **Timeless Series: Model TMPW**

- **All units incorporating one of the following glass systems:** AC Master—with Grids.
- **All units incorporating one of the following glass systems:** AC Master with SolarShine option, Eco Master, Armor Glass Plus, Energy Master III, Solar Master III, Thermal Master III or Ultra Master III—with or without Grids.

### **Timeless Plus Series: Models TPDH, TPHS, TPTS**

- **All units incorporating one of the following glass systems:** Eco Master, Armor Glass Plus, Energy Master III, Solar Master III, Thermal Master III or Ultra Master III—with or without Grids.

### **Timeless Plus Series: Model TPPW & All 5300 Specialty Shaped Products**

- **All units incorporating one of the following glass systems:** AC Master—with Grids.
- **All units incorporating one of the following glass systems:** AC Master with SolarShine option, Eco Master, Armor Glass Plus, Energy Master III, Solar Master III, Thermal Master III or Ultra Master III—with or without Grids.

### **5400 Series: Models 5402, 5405**

- **All units incorporating one of the following glass systems:** AC Master, Eco Master, Armor Glass Plus, Armor Max Plus, Energy Master III or Thermal Master III—with or without Grids.

### **5400 Series: Model 5401 & All 5400 Specialty Shaped Products**

- **All units incorporating one of the following glass systems:** AC Master—with Grids.
- **All units incorporating one of the following glass systems:** Eco Master, Armor Glass Plus, Armor Max Plus, Energy Master III or Thermal Master III—with or without Grids.

### **6000 Series: Models 6002, 6003**

- **All units incorporating one of the following glass systems:** AC Master—with Grids.
- **All units incorporating one of the following glass systems:** Eco Master, Armor Glass Plus, Energy Master III, Solar Master III, Thermal Master III or Ultra Master III—with or without Grids.

### **6100/6200 Series: Models 6153, 6155, 6156, 6157, 6158, 6253, 6255, 6256, 6257, 6258**

- **All units incorporating one of the following glass systems:** Eco Master, Armor Glass Plus, Energy Master III or Thermal Master III—with or without Grids.

### **6300 Series: Models 6302, 6303, 6352, 6353**

- **All units incorporating one of the following glass systems:** AC Master, Eco Master, Armor Glass Plus, Energy Master III, Solar Master III, Thermal Master III or Ultra Master III—with or without Grids.

### **6400 Series: Model 6402**

- **All units incorporating one of the following glass systems:** Armor Max Plus—with or without Grids.

### **StarView Series: Model SVDH, SVSH, SVHS, SVTS**

- **All units incorporating one of the following glass systems:** Eco Master, Armor Glass Plus, Energy Master III, Solar Master III or Thermal Master III—with or without Grids.

### **StarView Series: Model SVPW & All StarView Specialty Shaped Products**

- **All units incorporating one of the following glass systems:** AC Master—with Grids.
- **All units incorporating one of the following glass systems:** Eco Master, Armor Glass Plus, Energy Master III, Solar Master III or Thermal Master III—with or without Grids.

**Glass System Definitions:**

AC Master consists of one lite of clear and one lite of SolarControl Plus with argon gas fill.

Eco Master consists of one lite of clear and one lite of SolarControl Max with argon gas fill.

Armor Glass Plus, Armor Impact Plus and Armor Max Plus consist of one lite of laminated glass and one lite of SolarControl Max with argon gas fill.

Energy Master III is a triple-glass unit with one lite of clear and two lites of SolarControl Plus with argon gas fill.

Solar Master III is a triple-glass unit with one lite of clear and two lites of SolarControl Plus with a 50/50 krypton/argon blend gas fill.

Thermal Master III is a triple-glass unit with one lite of clear and two lites of SolarControl Plus with krypton gas fill.

Ultra Master III is a triple-glass unit with one lite of clear, one lite of SolarControl Max and one lite of SolarControl Plus with krypton gas fill.
